Thane Dykstra, President and CEO of Trinity Services, is not above a little bragging when he speaks about the organization's new supportive housing option in New Lenox.

"It is a gorgeous building," he beamed, during the grand opening of Prairie Trail at the Landings on May 12.

"It's probably my favorite building personally. But anybody can build a building. But that's not the challenge. And that's not what makes a difference.

"You heard from people who spoke before me about the importance of the staff members and the connections with each other. That's what's truly most important.

"There is so much good that happens here."

A Visit to Joliet's 1st Stop Won't Be Your Last

I've been in more than a few diners in my time. Din-

ers, not "family restaurants." Not to say diners are not for families. They are for everyone. True diners, IMHO, must have a counter and preferably tables instead of



Whatever hours they are open, the diner must serve both breakfast and lunch foods at all times. Despite what

McDonald's may believe, it's as easy to throw an egg and some bacon on the grill as it is a burger, any time of day.

Generally, they do not attract attention to themselves, except by the quality of their services, usually by word of mouth. Which, these days, includes social media.

Joliet's 1st Stop is a non-descript storefront in a small strip mall on South Chicago Street, maybe a half mile south of the more plush restaurants, like Chicago Street Bar and Grill, and Jitter's Coffee House, which offer great options as well.

"Go north of the viaduct, and the prices double," said Patrick Fanning, who opened Joliet's 1st Stop on April 1, 2021.

Patrick Fanning. Gray T-shirt and a wry smile. There is a little of Steve Buscemi about him, but not as scary. Great storyteller. Another necessity for a diner owner, as well as being a great cook.

Inside Joliet's 1st Stop is an atmosphere you could feel in many small towns. One that usually is across from a gas station, a small grocery store and a VFW. Walk inside 1st Stop and sit at the counter on a selection of chairs, or at one of the wooden tables.

As you gaze at the laminated menu (the only thing that's snazzy about this place) you forget that outside is one of the busiest avenues, with trucks and cars vying for position. Or that you left your car parked in a lot that hasn't seen a grader in a long while.

Don't give me that. It's not like we haven't parked on some dirt or gravel outside a good diner.

Fanning welcomes you either from behind the counter or a few steps away in the kitchen. Again, it's clean, but definitely no frills. He'll offer coffee, and you should take it. It's good and hot, and served in a large ceramic mug. Like welcoming a friend into his home kitchen in Elwood.

Depending on the time of day, the early-risers or overnight shift workers from the warehouse district to the south may have beaten you to the ham off the bone, or the potatoes to go with your eggs. But that still leaves you with a choice of some good, crisp bacon or homemade breakfast sausage, and rice or grits.

Also on the menu are diner staples such as oversized pancakes, omelets and biscuits and gravy, as well as a few high-falutin' offerings, like breakfast burritos and breakfast sandwiches. Lunches, no matter what time of day, include burgers, a monster Philly sandwich and a large garden salad.

I wish I had known the sausage was homemade, but the bacon was perfect, as were the over-easy eggs. For a city boy like me, grits were something I had never heard of until my brother Gordon mentioned it was one of the

offerings at mess when he was in basic training. Grits work fine, and they're better for you. Next time, I'll get there earlier.

"I wish it was more consistent," Fanning says of his business and running out of breakfast potatoes by 11 a.m. "You just never know. I went through 6 pounds of potatoes just this morning."

Fanning measures his supplies carefully. He has to. The price of cooking oil has doubled since he moved in to the former restaurant spot. To keep prices low, he'll look in local stores for the best deals on eggs, whole hams and even specials that will pop up that aren't on the menu.

One time, he found already cooked and sauced ribs, two for one. Fanning brought 'em back to the kitchen, threw them under the broiler for a nice char, and sold a slab for \$12,

including fries. Thus, was born a daily special.

A restaurant pro for the past 40 years – including a decade at Sunny's in Elwood - Fanning at one point had hit the road in a new RV toward retirement. That didn't last long.

"I have to stay busy," he said. My guess is he also missed the friends he made in the restaurant business in Elwood, some of whom now bring in their kids.

So, Tuesday through Friday, you'll find him behind the counter from 5:30 a.m. to 1:30 p.m.; 7 a.m. to 1:30 p.m. on Saturdays. Mondays open 5:30 to 10 a.m. Just him.

"I put a note on Facebook looking to hire someone. I said call or come in person. What happens? I get texts. I don't want texts. I want you to call or come in person.

"More coffee?" Yep. Fill 'er up.

"Now I know that Dominic won't have to travel far when he grows up and desires to live independently. This amazing opportunity is right here in his own hometown, and for that I am truly grateful.

"Congratulations to Trinity on opening this beautiful new housing complex for adults with developmental and intellectual disabilities."

During the open house, more than 100 guests toured the apartment complex that features 22, one-bedroom and three-three-bedroom units, each with its own kitchen, bathroom, living space and storage area.

The first floor features a lobby area, offices and a large community room. The building's first floor and common areas are staffed

by Trinity Services personnel, who provide residents with support, including budgeting, job counseling, social skills and cooking.

Our Rural Heritage

Only the name remains, the Jug Town



If you travel west on Lorenzo Road from I-55, you will come across a street named Jug Town Road. Most roads in this region lead to the town they are named after. But search as you might, you will not find Jug Town. However, if you go back in time to the mid-1850s, you would easily have found it. And that's what we will do today.

You don't have to be a farmer to know that to be successful, you must have good soil. The type of soil determines the crops you grow or the livestock you

lot. Clay is the main ingredient in pottery. And pottery was an absolute necessity in the household. Pottery vessels held everything from water to sauerkraut, from sausages preserved in their own fat to homemade cherry wine. In the kitchen, clay vessels were used to store butter and milk, to bake bread, beans, stews, and much more. On the farm, clay tiles were laid to drain swamp land or line the well.

In late 1855, William White came to this area from Utica, New York, where his family was engaged in the pottery business. Together

keep. When settlers first came to a place named Goose Lake, they knew one thing: The soil in the area was not good for farming. Bogs and swamps were everywhere, not to mention quicksand; good for the massive amounts of waterfowl to be found there, but not for much else. That is until 1855, when a man discovered a valuable commodity at the far west end of the lake – clay.

Perhaps in this day and age, that discovery would not mean much, but in the mid-19th century, it meant a

that rich soils lay below marshy areas, and draining them meant a huge increase in production.

Two different sites produced both tiles and household pottery. But pottery works were only part of the community that lived there. There were two boarding houses and at least four homes to house the workers and their families. There was also a school house, a communal room or hall, and at least two stores. The 1860 census tells us that there were nine households there, with a total of 55 individuals.

The stoneware produced there consisted of minimally decorated, salt-glazed jars, bowls (milk pans) and jugs. All of them more or less made individually, by hand. Thus, any Jug Town Pottery you may find today varies in size, shape and decoration.

mining the clay from the banks of Goose Lake, then transporting it to the workshop site. It was dumped into "clay pits" to freeze over the winter. Passing it, mixed with water to a proper consistency and then turned on wheels.

extruding clay through dies. a wire to about 24" lengths.

The tiles were dried, stacked into a kiln, then fired. After cooling, the tiles were stacked in the yard for transportation elsewhere. In the field, the tiles were joined together with collars, made slightly larger than the tiles.

The craftsmen who lived at Jug Town were highly skilled. They earned \$42.50 (\$1,400 today) per month, compared to average unskilled laborers who made only \$3.50 (\$115.00) per month. The less-skilled workers at the tile factory made \$26.00 (\$785) per month.

In the end, the firm of White and Walker went out of business; they were never able to pay back the \$10,000 they originally borrowed to start the pottery works. They soon discovered than transporting heavy, bulky, breakable goods over poorly developed swampy roads to

get to the I & M Canal was extremely costly. In addition, their remote location in the swamps of Goose Lake made marketing a problem. The partnership and pottery works were dissolved in 1866.

The 1874 plat of Grundy County shows two "old potteries" still on the map, but by 1890, they no longer appeared on the plat maps. By 1910, the majority of the buildings were in ruins, the foundations were removed and the land plowed over for planting. The large drying shed was still upright; it was divided in two and half moved to another farm site. The kilns lasted a bit longer.

In 1969, the State of Illinois purchased the site and other property to create Goose Lake Prairie State Natural Area. It is now on the National Register of Historic Places.

Natural Hummingbird Feeders:

The plants in your garden

Our "jewel of the bird world," the ruby-throated hummingbird, has been spotted in Will County for the last three weeks. Many people have their hummingbird feeders up, but what if you don't have the time to fill, tend and repeatedly wash a feeder, can you still attract hummingbirds?

Of course, do it the natural way -- with plants. And there is an added bonus, that nectar in the plants provides more nutrients than a feeder's sugar water does.

Certain plants evolved their plant structures to be pollinated by birds instead of insects. Here's a five-dollar word you can use to impress your gardening friends – orthinophilius -- meaning pollinated by birds instead of insects. So, when you look at a hummingbird with that long bill and even longer split tongue, envision a plant whose flowers are long and deep, the tubular flowers. These are particularly attractive to hummingbirds.

When planting to attract hummingbirds, we always

want to have a bird's eye view (pun intended). So, we often locate a hummingbird garden near the house and windows. Remember, birds, even the little hummingbird, often can't see the windows and can have fatal or near-fatal crashes.

If you have a garden near the windows that birds are attracted to, an easy fix is to put up a decal, sticker or even a white paper plant with two big black circle eyes (to a bird resembling an owl) to let them "see" the window and adjust their flight patterns. And if you ever do find a window crash victim, don't assume the worst. Often birds are just stunned; put them in an open box away from predators, and often, people are surprised to see their patient has recovered and flown the coop ... er box.

You also want to "garden messy" with different heights of flowers, with something blooming all the time. In nature, hummingbirds are found at forest edges, often near water, and in open prairies. It is also important to have safe ref-

uge for the little hummers to perch away from predators.

Did you know that the Chinese Praying Mantis is a predator of hummingbirds? So having a nearby shrub or small trees provides not only safety, but if you are lucky enough, a hummingbird might raise its young

There are many plants in all categories -- annual, perennial and biennial -that are attractive to hummingbirds. Hummingbirds do not have a strong sense of smell, so fragrance isn't an important feature when selecting hummingbird plants. Hummingbirds are visual food finders. They see in ultraviolet, so they see colors in far deeper and extra sensory ways than we humans do.

A recent 2020 study at Princeton found hummingbirds see an extra dimension of color. So, although traditionally we were taught to buy red and orange plants to attract hummers, they are also drawn to the rich blues and violets.

Which brings me to my top three favorite hummingbird plants. Far and above all others, the little fire engine red, Scarlet Cardinal Climber annual vine has hummers waiting in line on my cable wire. And you are not too late to plant it still. It is sold as seeds by many seed companies, and I can usually find it in any big box store display.

To plant, nick seeds with a file, sandpaper or, if you are lucky, the seed company does it for you. You will see a tiny white spot on the coal black, big seed if they did. Since they have a big, hard seedcoat, nicking helps with germination. Soak

for 24 hours, then plant in a sunny spot or container. Scarlet Cardinal Climber is best planted when the soil is warm, after Memorial Day

head start by starting some

inside in April.

Second, blue salvia -- particularly Salvia guaranitica (look for common names like blue anise sage, Brazilian sage, Salvia black and blue, Indigo Spires salvia). This sage is native to Brazil, Paraguay, Uruguay and northeastern Argentina. The leaves of this plant were purportedly used by the

Guarni people of Brazil as a sedative (Source: University of Wisconsin). I know what you are thinking: Blue? Yes. Hummers will line up for this tender perennial plant (dies if you leave out in winter/can overwinter in ho use).

Third, the native cardinal flower (Lobelia cardinalis) is a hummingbird favorite. This hardy perennial plant gets 2-3.5 feet tall, and does great in a wet, sunny, or part sun location. When we plant perennials for wildlife, looking at bloom time is critical, and cardinal flower is perfect for hummingbirds with a late summer/early fall flowering time. About this time, hummingbirds are fueling up for their migration south.
